The accused **Subhankar Bouri** is produced from JC and he is taken into custody and remanded to JC further till next date.

Ld. Spl. P.P and Ld. Defence lawyer are present.

The record is taken up for consideration of charge.

It appears that C.S have been submitted against the accused person after conclusion of investigation initiated on the basis of written complaint lodged by the mother of the V.G that on 6.5.2024 accused person kidnapped and wrongfully confined the minor victim of this case and committed aggravated penetrative sexual act upon the minor V.G. The materials available on record are sufficient to prove and harbour the charge that may be framed against the accused person.

Strict compliance U/s.207 Cr. P.C and R.91A of Cr.R.O.

Accordingly charge is framed against accused U/s.363/365 of the IPC and U/s.6 of the POCSO Act.

The charge so framed is read over and explained to the accused person to which he pleaded not guilty and claimed to be tried.

The bail petition dt.16.7.2024 is taken up for hearing.

Ld. Defence lawyer submits that the accused has been languishing in custody since 9.5.2024. He is innocent. He is local man. C.S has already been submitted in this case. So on any terms and condition he prays for bail.

Ld. Spl. P.P raised objection saying it is a case of U/s.363/365 of the IPC and U/s.6 of the POCSO Act and there are sufficient materials against the accused.

Defacto complainant raised no objection against the prayer for bail.

Heard all sides. Considered the materials on record. As C.S has already been submitted in this case, there is no need to detain the accused behind the bar further. Hence the prayer for bail is considered and allowed. The accused may find bail of Rs.4000/- with 02 sureties of Rs.2000/- each, subject to the satisfaction of the Ld. CJM, Purulia.

Let a copy of this order be sent to the Ld. CJM, Purulia for information and necessary action.

Dates for trial is fixed hereunder.

To 26.11.2024, 27.11.2024 and 28.11.2024 for appearance of accused **Subhankar Bouri** and for evidence from prosecution side.

Prosecution is directed to produce the witnesses and alamats, if any, on the dates fixed. Issue summons accordingly.

Charge framed against the accused person in separate sheet is kept with the record.

If on bail to 26.11.2024 for appearance, I.d to J.C.
