Considering the nature of the present case, the prayer of the I.O for Medico-Legal Examination of both the accused persons namely, **Azad Ansari @ Pintu** and **Sk. Sakil @ Sk Sahid** is hereby allowed for the interest of investigation.

The Superintendent, Deben Mahato Govt. Medical College & Hospital, Purulia, is hereby requested to make necessary arrangement for the Medico-Legal Examination of both the accused persons namely, **Azad Ansari @ Pintu** and **Sk. Sakil @ Sk Sahid** as early as possible.

The prayer for P.C. of both the accused persons namely, **Azad Ansari @ Pintu** and **Sk. Sakil @ Sk Sahid** is taken up for consideration and the I.O. is present on dock. Purpose of police custody of both the accused persons, in view of the alleged offence under the P.O.C.S.O. Act, as made out by I.O., appears to be reasonable and in the interest of proper investigation of this case. Such prayer has also been recommended by the Deputy Superintendent of police(D & T),Purulia.

Accordingly prayer for police custody of both the accused persons namely, Azad Ansari @ Pintu and Sk. Sakil @ Sk Sahid is hereby allowed for the interest of investigation. Both the accused persons be remanded to police custody till 22-08-2024, and the I.O. is directed to produce both the accused persons before this court on 22.08.2024 at 10:00 a.m.

The I.O. is directed not to torture both the accused persons in police custody. He is also directed to get the above named accused persons examined by a Government Medical Officer. He is also directed to strictly obey the guidelines as directed by the Hon'ble Supreme Court in this regard.

L.S.I, Arpita Bhatta of Purulia(T) P.S, the I.O of this case has filed a petition through Ld. Spl. P.P. with a prayer for supply copy of the recorded statements of the V.G & the defacto complainant U/s.183 BNSS for the interest of investigation.
