This day is fixed for evidence of CSW no.2

All three accused persons of this case namely, Saumitra @ Rana Banerjee, Sundar @ Bhairab Bauri and Biswajit @ Bhuka Mardanya are produced from CH and taken into custody.

Ld. PP-in-charge is present with one witness namely Sri Jayanta Kumar Gorain and filed hazira.

The above named witness has been examined by the prosecution as the P.W.7 and the said witness was discharged after his cross-examination in full by the Ld. Advocates of all three accused persons.

During the examination of the PW7, his signature on the Inquest Report of Police was marked as Exhibit-P-2/2/PW7. The written complaint and the signature of PW7 on it were marked as Exhibit-P-3/PW7 & Exhibit-P-3/2/PW7 respectively. Besides, the signatures of the witness on seizure-list dated 25-06-2022 by which blood stained etc. and motor cycle were seized were marked as Exhibit-P-4/3/PW7 and Exhibit-P-5/3/PW7. Moreover, the seized sandal was produced and identified by the witness and it was marked as Exhibit-MO-1/PW7 (objected to).

No other witness has turned up today.

It is pertinent to note here that two supplementary records of Ld. CJM, Purulia forwarded by the Ld. Sessions Judge, Purulia on 14-12-2023 have been received by this Court. The 1st supplementary record with order dated 01-12-2023 passed by the Ld. CJM, Purulia for forwarding the FSL Report no.6263FSL/Bio/Phys/4776/22 dated 21-11-2023 in four pages along with the forwarding of the Officer-in-charge of Manbazar P.S. dated 30-11-2023 has been received by this Court. The 2nd supplementary record dated 14-12-2023 from the Ld. CJM, Purulia containing supplementary charge sheet vide no.93/23 dated 08-12-2023 with annexure containing FSL no.5216 FSL dated 09-09-2022 and the copies of the supplementary charge-sheet annexed FSL Reports has been received by this Court.

Let the two supplementary records with FSL Reports and supplementary charge-sheet be kept with the record.

Let the copies of supplementary charge sheet annexed relied documents be supplied to the Ld. P.P-in-charge as well as all the accused persons at once.

Case is adjourned today.

The above named three accused persons are remanded to CH with the direction to produce the accused person before this Court on the next schedule.
