This day is fixed for evidence of CSW nos.11 & 14 as per schedule.

All three (03) accused persons namely Rana @ Saumitra Banerjee, Sundar Bauri and Biswajit @ Bhuka Mardanya are produced from CH and taken into custody.

Ld. PP-in-charge is present with one witness namely Sri Sambhu Singh Sardar & C/1055 Santimoy Samanta and filed hazira.

Witnesses Sri Sambhu Singh Sardar & C/1055 Santimoy Samanta were examined-in-chiefs in full as the PW12 & PW13 respectively. Thereafter, PW12 & PW13 were discharged after their cross-examinations in full by the Ld. Advocate on behalf of Rana @ Saumitra Banerjee and the said cross-examinations were adopted by the Ld. Advocates of the accused namely Sundar Bauri and Biswajit @ Bhuka Mardanya.

During examination of PW13, his signature on the seizure-list dated 01-07-2022 by which wallet and the log were seized, signature of the said witness on label of those seized things and signature of the said witness on the document of seized currency notes were marked as **Exhibit-P-15/1/PW13**, **Exhibit-P-16/1/PW13** and **Exhibit-P-17/1/PW13** respectively. Besides, the seized wooden log was produced and identified by the PW13 and marked as **Exhibit-MO-4/PW1**; the black wallet containing Epic Card, Aadhaar Card, Driving License and PAN Card in the name of Saumitra Banerjee was marked as **Exhibit-MO-5/PW13 collectively**; three currency notes of Rs.10/- and one currency note of Rs.100/- were marked as **Exhibit-MO-6/PW13 collectively**.

On the other hand, during cross-examination of the PW13 the Ld. Defense Counsel showed the seizure-list dated 01-07-2022 to the witness and confronted about its content and as such, the seizure-list dated 01-07-2022 by which black wallet and log were seized was marked as **Exhibit-D-2/PW13**.

No other witness has turned up today.

Accordingly, the case is adjourned today.
