It appears from the Supplementary Case Record that on 17.09.2023, during holiday police file, the court of Ld. CJM, Purulia received from Joypur P.S. the written FIR dt.16.09.2023 lodged by SI Sanjoy Diger of Joypur P.S, the formal F.I.R. dt.16.09.2023 of Joypur P.S Case No.117/2023, dt. 16.09.2023 U/s.21(c) of the NDPS Act against 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh and that said 02 accused persons were produced before the Ld. CJM, Purulia on 17.09.2023 and that Ld. CJM, Purulia was pleased to send said 02 accused persons to J.C till today with a direction to produce said 02 accused persons before this court today.

The case is registered in the CIS.

Both said 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh have been produced before this court today from J.C.

Said 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh are taken into custody.

On perusal of the case record it appears that on 17.09.2023 the I.O of this case, namely, S.I, Nagendranath Das of Joypur P.S filed one petition praying for sending said 02 accused persons to P.C for 14 days. Said petition is pending for disposal.

Perused all those documents. Let the documents be kept with the case record.

Ld. Advocate Mr. Nabin Kr. Sao, appointed by DLSA, Purulia Sadar is present today to represent both the accused persons.

S.I. Nagendranath Das of Joypur P.S., the I.O. of this case, is present with C.D.

Now the prayer dt.17.09.2023 of the I.O for taking said 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh in police custody, is taken up for consideration.

In the petition dt.17.09.2023, the I.O of this case has prayed for taking said 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh in Police Custody for 14 days for arrest of other co-accused, etc. The prayer has been duly recommended and forwarded by the Dy. Superintendent of Police (D & T), Purulia.

Perused the materials in the case record. Also perused the materials in the case diary. Heard both the sides.

Ld. Spl. P.P has submitted that both the accused persons are required to be sent in police custody **for 14 days** for detecting the racket and to verify the statements made by the accused persons and that as the accused persons belong to the neighbouring State Jharkhand, the I.O is required to make investigation in the State of Jharkhand and the I.O of this case is required to go to Jharkhand with the present accused persons for the purpose of investigation and for that reason at least 14 days' P.C is required. Considered.

Considering the materials available in the C.D and the nature of the present case and also considering the fact that the I.O wants to go to Jharkhand with these accused persons for the purpose of investigation, **the instant prayer of the I.O for Police Custody of the present 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh, is hereby allowed and said 02 accused persons namely, 1) Om Prakash Prasad and 2) Dablu Kumar Singh are hereby sent to the Police Custody for 13 days i.e up to 01.10.2023.**
