**Ld. Advocate Mr. Biplab Kr. Sen, appointed by DLSA, Purulia, is present for both the accused persons.**

**Today is fixed for production of both the accused persons, namely, Dablu Kr. Singh and Om Prakash @ Guddu from J.C and for report in final form and also for hearing of the petition dt.27.09.2023 of the I.O for adding S.379/411 IPC and 25 (1)(a) of the Arms Act and also for hearing of the bail petition dt.15.12.2023 for both the accused persons.**

**The I.O has not yet submitted the report in final form.**

Said bail petition dt.15.12.2023 for both the accused persons is taken up for hearing.

Perused the materials in the case record also perused the C.D. Heard both the sides.

Ld. Advocate for the defence side has submitted that present accused persons have been falsely implicated in this case and that the accused persons are in custody since long and that they may be released on bail on any term and condition.

Ld. Spl. P.P has raised strong objection to the instant prayer for bail of this accused persons stating inter alia that the quantity of the seized narcotic is of commercial quantity and that the investigation is in progress and at this stage the accused persons should not be released on bail.

On perusal the materials in the case record as well as in the C.D it appears the investigation of this case is going on and that 12840 grams of Codeine Mixture was recovered from the possession of the accused persons.

Considering the nature of the present case and the stage of investigation, the prayer for bail of the present 02 accused persons is hereby considered and rejected at this stage.

The bail petition dt.15.12.2023 for both the accused persons is accordingly disposed of.

Said petition dt.27.09.2023 of the I.O for adding S.379/411 IPC and 25 (1)(a) of the Arms Act, is now taken up for consideration.

Perused the materials in the case record as well as in the C.D. Heard Ld. Spl. P.P. Considered.

At the time of hearing Ld. Spl. P.P has submitted that in said petition dt.27.09.2023 the I.O has prayed for adding S.379/411 IPC and 25 (1)(a) of the Arms Act but subsequently the seized items have already been re-seized by the I.O of another case and the present prayer of the I.O is to be rejected.

On perusal of the case record as well as C.D it appears that the I.O has prayed for adding S.379/411 IPC and 25 (1)(a) of the Arms Act but subsequently by petition dt.18.10.2023, the I.O of this case has informed said matter to this court along with the copy of the order dt.12.10.2023 of the Ld. CJM, Purulia passed in G.R Case No.1591/2023 and that copy of the Seizure List dt.14.10.2023 from which it appears that in respect of those seized gold ornaments, money, arms, etc, a specific case being Purulia (T) P.S Case No.137, dt.29.08.2023 U/s.395/120B/201/379/412/414 IPC and 25/27 of the Arms Act has already been started and that the I.O of this case has already handed over those seized items to the I.O of said specific case and that the I.O of said specific case has re-seized those items under proper
