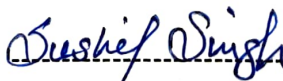

(Delivered On 3rd March, 2024)

Accused produced along with charge-sheet by Sangavi Police Station. The accused voluntarily pleaded guilty for the offence punishable under section 279 of the Indian Penal Code. I have explained him the consequences of his pleading guilty. In spite of that, he pleaded guilty and submitted to release him with minimum fine. It is further submitted that he is very poor and no one is there to look after his family. His plea being voluntarily made, I accept the same and proceed to pass the following order:-

1. The accused is hereby convicted for the offence punishable under section 279 of the Indian Penal Code vide section 252 of Cr.PC. and shall pay fine of Rs. 5000/- (Rs. Five Thousand Only) in default he sentence to suffer S.I. for one month.
