

CBI 287/2019 CBI Vs N E TELEVISION NETWORK PVT LTD

Despite directions of payment of cost, the cost has not been paid. Further, the accused Nikhil Behl has appeared through VC and was taking a call during the course of VC proceedings, while keeping his audio on. It appears to the Court that the accused is adopting a very casual attitude in appearing before the Court through VC and not following the Video Conferencing Rules, 2025 of the Hon'ble High Court of Delhi and such conduct, must not be further encouraged.

Therefore, the accused Nikhil Behl (A-10) is burdened with a cost of Rs. 5,000/- to be paid to the PM National Relief Fund on or before the next date of hearing, in addition to the cost imposed vide Order dated 21.01.2026. The accused Nikhil Behl (A-10) is also

directed to appear before the Court in person, on the next date of hearing. Any non-compliance of the directions, shall be viewed adversely by the Court.
