Today is fixed for consideration of charge.

Both the accused persons, namely, Golu Sharma @ Bikki @ Vikki Sharma and Rakesh Kumar Rajak are produced from J/C.

Ld. Lawyer for the accused persons and ld. P.P. are present.

The case record is taken up for consideration of charge.

The learned P.P. opens his case in support of the charge.

Heard the learned P.P as well as Learned Advocate appearing for the accused persons.

Perused the case diary and other materials on record. Considered.

Ld. P.P. submitted that one Nayana Das Karmakar informed the I/C Purulia(T) PS that on 28.08.22 at about 12:00 noon the present accused persons who were carpenter entered into their house at Darji para, Garikhana and expressed their willingness to one Nandita Das Karmakar who is the wife of the owner of the house that they want to purchase old and rached wood from them. Thereafter accused Golu Sharma and Rakesh Kumar Rajak went to the roof taking the key from said Nandita Das Karmakar and thereafter the said Nandita Das Karmakar also went to the roof and did not return back. The accused persons committed dacoity and murdered said Nandita Das Karmakar whose dead body was thereafter found in the staircase of their house. The accused persons also committed murder of the maid servant of the said house namely Parbati @ Upasi Baidyakar and concealed the dead body of said Parbati @ Upasi Baidyakar in the room of the son of said Nandita Das Karmakar namely Subhojit Das Karmakar covering the said dead body with bedding keeping the said room under lock and key and fled away.

On perusal of the materials on record, it appears that there are sufficient grounds i.e. prima facie materials for framing of charge against the accused persons namely, Golu Sharma @ Bikki @ Vikki Sharma and Rakesh Kumar Rajak under section 302/120B/201/394/411/34 I.P.C.

Charge is framed in separate sheets of paper against both the accused persons under section 302/120B/201/394/34 I.P.C. and u/s 411 IPC against accused Golu Sharma @ Bikki @ Vikki Sharma.

Let the separate sheet be kept with the record.

The particulars of charge has been read over and explained to the accused persons in vernacular language, to which the accused persons individually pleaded not guilty by saying "Ami Nirdosh" and claims to be tried.

The schedule of trial is fixed hereunder:

To 03.04.23 for evidence of C.S.W No.1

To 04.04.23 for evidence of C.S.W No.2

To 05.04.23 for evidence of C.S.W No.3

To 06.04.23 for evidence of C.S.W No.16

Prosecution to furnish process for issuing summons upon the witnesses at once. Issue summons accordingly.

To **03.04.2023** for production of the accused persons.

I.O is directed to monitor the trial and ensure the presence of the witnesses and production of alamat in the Court during trial.

Let the accused persons be remanded to J/C till 03.04.23.

Let a copy of the order be sent to the O.C of the concerned P.S for information and necessary action.
