Commitment order:

1. Challan against the above named accused has been forwarded by Officer in charge of Police Station, P.S. Beas, District Amritsar, to face trial under Sections 302, 328, 323, 148, 149 IPC.
2. The FIR in question was registered on account of death of son of the complainant namely Deepak Singh. He suffered the statement before ASI Sukhdev Singh that on 22.04.2020 at around 9:30 p.m., when he along with his friend Honey were going back home after rendering their services at Gurudwara Shri Guru Teg Bahadur Sahib, and when they crossed the home of Puran Singh son of Prem Singh, then Puran Singh hit Deepak Singh with the dang on his head from the back side as a result of which deceased Deepak

Singh fell down thereafter, accused Puran Singh, Ladi, Kala and Palwinder Kaur wife of Puran Singh started beating Deepak Singh as a result of which he got unconscious. The deceased Deepak Singh was admitted to Civil Hospital, Baba Bakala Sahib from where he was referred to Guru Nanak Dev Hospital, Amritsar but he was taken to Guru Ramdas Hospital, Amritsar. On 03.05.2020, one telephone call was received in the police station from PGI Hospital, Chandigarh that Deepak Singh has succumbed to the injuries. On his this statement, the FIR under Sections 302, 328, 323, 148, 149 IPC was registered. Investigation helmed. After completion of investigation, challan was presented against accused Kuldeep Singh @ Kala and Palwinder Kaur and the copies of challan were supplied to the accused free of cost.

3. From the facts as enumerated in the FIR, prima facie offence punishable under Sections 302, 328, 323, 148, 149 IPC is made out. The offence under Section 302 IPC is exclusively triable by the Ld. Court of Sessions. Hence, the present case is hereby committed to Ld. Court of Sessions at Amritsar, for 05.09.2022. Jail authorities are directed to produce the accused Kuldeep Singh @ Kala and Palwinder Kaur before the Court of learned Sessions Judge Amritsar, on the date fixed at 10.00 a.m. The commitment of this case to Ld. Court of Sessions, Amritsar be notified to Public Prosecutor.

Ahlmad is directed to send the record of the present case along with the documents, complete in all respects to the Court of learned Sessions Judge, Amritsar, well before the date fixed.
