COMMITMENT ORDER:-

1. Accused above named has been forwarded by the SHO of
Police Station Sadar Patti District Tarn Taran to face trial for offences
punishable under Sections 307, 427, 148, 149 of IPC & 25/27/54/59 of
Arms Act.

2. In brief, the prosecution version is that on 14.02.2019 ASI
Nirmal Singh was present at Police Station Sadar Patti. MHC Jarnail

Singh handed over to him three MLRs of injured Harjinder Singh, Harpreet Singh and Ranvir Singh for recording statements of the injured. ASI Nirmal Singh alongwith HC Ranjit Singh, HC Dharam Singh, HC Avtar Singh and C. Gurbinder Singh went to Civil Hospital Patti and moved application to concerned doctor regarding fitness of all three injured to suffer statement. Concerned doctor opined all the three injured fit to make statement. Thereafter, Harjinder Singh son of Balbir Singh resident of village Boparai got recorded his statement to ASI Nirmal Singh to the effect that :

“ That he is resident of village Boparai and is Sarpanch of said village. He has his residence at Patti Road Moud Chuslewar opposite to Petrol pump. Some of the residents have drained water of their houses in Government outlet (Khal) by digging the land besides the main road. Due to widening of the road, the pits got closed. On 13.02.2019 at about 5.30 P.M., when he alongwith Harpreet Singh son of Iqbal Singh driver were putting pits, Satnam Singh son of Piara Singh, Piara Singh son of Sohan Singh, Raj Kaur wife of Satnam Singh residents of village Chuslewar, who have been residing towards Northern side of his house, came there and asked to stop and further stated that they will not let them put pits. He directed the messian to stop work and thereafter he alongwith Harpreet Singh and Ranbir Singh went to his house and when they were talking to one another on the roof of their

house, Satnam Singh armed with rifle .12 bore double barrel, Tasbir Singh, brother-in-law of Satnam Singh armed with .32 bore revolver, Gurinder Singh son of Tasbir Singh armed with .12 bore single barrel rifle, Nachattar Singh armed with Desi Katta Pistol, Raj Kaur empty handed alongwith four unknown persons carrying dangs came there raising Lalkaras. Raj Kaur raised Lalkara that Harjinder Singh Sarpanch alongwith his companions be done to death by bullets and be taught a lesson for putting pits in the way of their house. Then Satnam Singh opened fire of .12 bore rifle carried by him towards them. The pellets of the bullet hit on his left arm just below the bicep and on left side of his chest. Harpreet Singh sustained pellets injury on his left eye and right side of his chest and stomach. Then Gurinder Singh fired from his .12 bore single barrel rifle which hit on the forehead, finger of right hand and on the chest and stomach of Ranbir Singh. Tasbir Singh opened fire from his .32 bore revolver and Nachattar Singh opened fire from his pistol, pellets of whom hit the windows and glasses and walls of their house. They all fell down on the roof of the house and raised shouts of “Maar Ditta Maar Ditta”. On listening to their shouts, his brother Sukhjinder Singh also raised shouts of “Maar Ditta Maar Ditta”. Then all the accused fled away from the spot with their respective weapons. Entire occurrence was seen by Sukhjinder Singh and Mahabir Singh. Sukhjinder

Singh arranged vehicle and took all of them to Civil Hospital Patti.

The motive for causing injuries is that the accused were stopping them from putting pits for drainage of water. Action be taken against them”.

3. On the basis of this statement, FIR against the accused Satnam Singh, Raj Kaur, Tasbir Singh, Gurinder Singh, Nachattar Singh and four unknown persons was registered. Accused Satnam Singh was arrested. Medical evidence was collected, statement of witnesses were recorded. On completion of investigation, Challan against accused Satnam Singh was presented on 13.05.2019. It is apposite to mention that accused Tasbir Singh and Nachattar Singh were kept in column No.2 as proclamation proceedings were pending against said accused. Accused Gurinder Singh and Rajbir Kaur @ Raj Kaur were also kept in column No.2 of the final report as inquiry is pending before S.P. (D), Tarn Taran.

4. On appearance of the accused Satnam Singh in the Court, copies of challan and necessary documents as relied upon by the prosecution were supplied to accused free of costs as required u/s 207 of Code of Criminal Procedure, 1973 (hereinafter referred to as **Cr.P.C.**).

5. Accused Satnam Singh has been arrested in the present case for alleged commission of offences punishable under Sections 307, 427, 148, 149 of IPC & 25/27/54/59 of Arms Act. The offence punishable under Section 307 of IPC is exclusively triable by learned Court of Sessions. So, this case is committed to the Court of learned Sessions

Judge, Tarn Taran for **14.12.2019**. Accused on bail is directed to appear in the Court of learned Sessions Judge, Tarn Taran on **14.12.2019 at 10.00 A.M.** Sharp. Order of commitment be notified to the Public Prosecutor, Tarn Taran. Ahlmad of this Court is directed to send the file, complete in all respects, to the Court of learned Sessions Judge, Tarn Taran, well before the date fixed.
