2. Brief facts of this prosecution case as emanated from final report submitted under Section 193 of BNSS, 2023 are that on 24.04.2026, the police received information regarding injured admitted at hospital. Upon said information, the police officials reached at the hospital where Maninder son of Manjeet Singh moved an application before the police to the effect that on 22.04.2026, he along-with Foji and Happy was doing harvesting in the fields of Phool Singh. In the meantime, 10-12 boys armed with weapons started assaulting them where Rimpay and Ajay suffered injuries and they were taken to the hospital. When he came back to the house and inquired about the persons who assaulted him, Foji and Happy and came to know that injuries were caused by Jaibir, Akash, Sonu, Ajay, Golu, Shubham, Vedpal, Ravinder, Naveen, Arjun and Bholu. On 23.04.2026 at about 02:00 AM, all the above said boys armed with weapons entered into the house of Phool Singh and assaulted him, Happy and Foji with the intention to kill and damaged the vehicles. The accused persons left after causing injuries. In the end, it has been requested to initiate legal action against the accused persons.

3. On the basis of above-said application, formal FIR was registered, Investigation was carried out and accused persons were arrested and produced before the Court. On completion of investigation, final report under Section 193 of BNSS, 2023 was submitted.

4. Copies of challan and other documents has been supplied to

the Ld. Counsels of the accused persons free of cost under Section 231 of BNSS, 2023.

5. On perusal of the contents of final report submitted under Section 193 of BNSS, 2023, a *prima-facie* case for the commission of offences punishable under Sections 109(1), 115, 118(1), 190, 191(3), 324(6), 333, 351(3), 117(2), 118(2) & 238(b) of BNS, 2023 have been made out. Since, the offence punishable under Section 109 of BNS, 2023 is exclusively triable by the Court of Sessions, therefore, the present case is committed to the Court of learned Sessions Judge, Rohtak for **13.08.2026**. Reader is directed to prepare the requisite Calendara. The Jail Authority concerned is directed to produce the accused persons in custody named above before the learned Sessions Judge, Rohtak, on the date fixed i.e. **13.08.2026** at 10:00 AM sharp, subject to the provisions of bail as provided in BNSS, 2023, during and until the conclusion of the trial. A separate intimation in this regard shall be sent to The Jail Authority concerned immediately. As the committal order has been pronounced in the presence of learned APP, so there is no need for separate notification in this regard. Case file be sent to the concerned Court well in time.
