Today is fixed for hearing.

Both petitioner No.1 and petitioner No.2 are present in Court.

Ld. Advocates of both sides are also present.

Before taking up the matter this Court takes an endeavour to reconcile the dispute between the parties so that they may resume their conjugal life once again. However, the attempt of reconciliation fails.

The case record is taken up for hearing.

Both sides filed their affidavit-in-chief. Petitioner No.1 and petitioner No.2 are examined one after another.

Heard Ld. Advocates for both the parties.

Considered.

Now, the case is taken up for passing order.

This is a petition u/s 13B of the Hindu Marriage Act, 1955 filed by the Petitioner no.1 **Smt. Mousumi Mondal (Pramanick)** and Petitioner no.2 **Sri Prabir Pramanick**, praying for dissolution of marriage by a decree of divorce.

Petitioners nos. 1 & 2 have appeared before this Court today.

The original petition u/s 13B of the Hindu Marriage Act, 1955 was filed on **06.01.2026**. The second motion is taken up on expiry of the statutory period of six months after the date of presentation of the petition referred above. The Marriage Certificate is marked as **exhibit-1**.

During inquiry, it appears that the parties are living separately for a period of one year or more and they have not been able to live together and accordingly, have mutually agreed to dissolve the marriage.

An attempt of reconciliation is made but failed.

This Court is satisfied that a marriage has been solemnized between the parties and the averments made in the petition are true for passing a decree of divorce declaring the marriage to be dissolved with effect from the date of decree.

Hence, it is

O r d e r e d

that the suit be and the same is decreed on consent but without any order as to cost.

The marriage solemnized on **28.02.2011** and registered on **01.04.2011** between the petitioners namely, **Smt. Mousumi Mondal (Pramanick)** and **Sri Prabir Pramanick** is dissolved by a decree of divorce u/s 13B of the Hindu Marriage Act, 1955.

The matter regarding the custody and/or the visitation rights of the minor male child of the parties namely Pratim Pramanick, shall be guided in terms of Paragraph no. 4 of the plaint.

Decree be drawn accordingly.
