The accused Sujit Kumar Mahato (21 years) is brought under arrest and produced before this Court along with relevant documents. He is taken into custody and remanded to J/C.

None represent the accused. No bail application has also been filed.

The Chief of LADCS, Alipore, South 24-Parganas is directed to appoint one Ld. Advocate to represent the accused positively on the next date fixed.

I.O of this case has made prayer for P.C of this accused till 04.06.2026 for the purpose of investigation. I.O. is present with C.D.

Ld. Advocate for the accused has raised objection against the PC prayer filed by the IO.

I have heard the IO as well as the Ld. Special PP and the Ld. Advocate for the accused. I have perused the materials as available in CD.

It is a case under sections 137(2)/64(1)/127(3)/3(5) BNS and Sec. 4 of POCSO Act, 2012. It appears from the PC prayer of the I.O that prayer of I.O for PC of the accused has been forwarded by superior officer. From the submission of prosecution it reveals that I.O requires PC of this accused for the purpose of verifying the statement of the accused and conducting his medico-legal examination for the purpose of investigation of the case. So, for the purpose of investigation the prayer of PC requires to be allowed and the other prayers of the I.O are also considered and allowed.

Accused Sujit Kumar Mahato is remanded to police custody till **25.05.2026**. I.O is further directed to observe the guidelines of the Human Right Commission and direction of the Hon'ble Supreme Court regarding police custody of the said accused person. I.O is also directed to take all necessary steps for medical check-up of the accused at the regular intervals and not to make any kind of torture during P.C period.

Other prayers filed by the IO are considered and allowed.

The Professor & HOD, FSM, Medical College and Hospital, Kolkata is requested to conduct the medico-legal examination upon the accused send the report as early as possible.

The I.O is also directed to produce the accused person to the hospital on the scheduled date.

Fix **25.05.2026** for production of the accused from PC and I.O's report.
