The accused Sujit Kumar Mahato (21 years) is produced before this Court from J/C.

One bail application has been filed on behalf of the accused. The same is taken up for hearing in presence of all sides.

Ld. Advocate for the accused has submitted that the accused is innocent and has been falsely implicated in this case. Ld. Advocate has further submitted that his client is in custody for a considerable period and charge sheet has already been submitted in this case after completion of investigation. Thus, he prayed for bail of the accused person in any condition.

Ld. Special P.P. raised objection against the prayer for bail.

Defacto complainant is personally present in Court and has raised objection against the prayer for bail.

Heard all sides. Perused the materials in CD.

From the materials available in record including the statement of the VG recorded u/Sec.183 BNSS and medico-legal examination report of the VG, I find that there are sufficient incriminating materials against the accused showing his involvement in the commission of alleged offence. Thus having considered the nature and gravity of the offence, I am not inclined to enlarge the accused person on bail. Hence, the prayer for bail is rejected.

Accused Sujit Kumar Mahato be remanded to J/C.

At this stage accused Mala Mahto @ Malo Mahato, Komal Mahato @ Kamal Mahato and Mina Devi surrender today before this Court and filed a petition along with fresh Vakalatnama praying for bail. They are taken into judicial custody.

A bail petition has been filed on behalf of the accused.

Ld. Advocate for the accused submitted that Charge Sheet has been submitted against the accused and summon was issued against these three accused and the principal accused has already been enlarged on bail. Thus he prays for bail.

Ld. Special P.P raised objection.

Heard both sides. Perused the materials in record

Having considered the materials in record and also considering that Charge Sheet has already been submitted and summons were issued

against these three accused persons, I am inclined to enlarge these accused persons on bail.

Accordingly, accused Mala Mahto @ Malo Mahato, Komal Mahato @ Kamal Mahato and Mina Devi may find bail of Rs. 2,000/- (rupees two thousand only) each with one surety of like amount each subject to satisfaction of learned C.J.M Alipore with condition that the accused persons shall attend the Court on each and every date fixed i.d to J.C.

Fix 03.10.2026 for production of accused Sujit Kumar Mahato and appearance of accused Mala Mahto @ Malo Mahato, Komal Mahato @ Kamal Mahato and Mina Devi and consideration of charge.
