Three accused persons, namely, 1. Mithila Dutta @ Mili Dutta @ Mili Bose (42 years) 2. Puja Dey (27 years) and 3. Sujata Das @ Puja (34 years) are produced before this Court from JC physically.

The bail applications of the accused persons are taken up for hearing in presence of all sides.

Ld. Advocates for all the three accused persons have submitted that the accused are innocent and have been falsely implicated in this case. Ld. Advocates have further submitted that his clients are in custody for a considerable period. Thus, he prayed for bail of the accused persons in any condition.

Ld. Special P.P. raised objection against the prayer for bail.

Defacto complainant has raised objection against the prayer for bail.

Heard all sides. Perused the materials in CD.

Having considered the nature and gravity of the offence and early stage of investigation, I am not inclined to enlarge the accused persons on bail. Hence, the prayers for bail are rejected.

At this stage the prayer of the IO for PC of accused Mithila Dutta @ Mili Dutta @ Mili Bose and Puja Dey is taken up for consideration.

I.O of this case has made prayer for P.C of accused Mithila Dutta @ Mili Dutta @ Mili Bose and Puja Dey till 16.03.2026 for the purpose of investigation. I.O. is present with C.D.

Ld. Advocates for the accused persons have raised strong objection against the prayer of these accused.

I have heard the IO as well as the Ld. Special PP and the Ld. Advocate for the accused. I have perused the materials as available in CD.

It is a case under sections 61(2)/96/99/98/143 BNS read with Section 4/17/21 of POCSO Act and 3/4/5/6/7 of Immoral Traffic (Prevention) Act. After considering the jail interrogation of the two accused it appears that there are sufficient grounds for which the PC of the named accused is required at this stage for hunting down the active members of

a human trafficking racket which involves the trafficking of minor girls for allegedly engaging them in sexual exploitation in lieu of money. So, for the purpose of investigation the prayer of PC requires to be allowed. Accused **Mithila Dutta @ Mili Dutta @ Mili Bose and Puja Dey** are remanded to police custody till **10.03.2026**. I.O is further directed to observe the guidelines of the Human Right Commission and direction of the Hon'ble Supreme Court regarding police custody of the said accused persons. I.O is also directed to take all necessary steps for medical check-up of the accused at the regular intervals and not to make any kind of torture during P.C period.

Fix **10.03.2026** for production of accused Mithila Dutta @ Mili Dutta @ Mili Bose and Puja Dey from PC, production of accused Sujata Das @ Puja from J/C and I.O's report.

Let copy of this order be sent to the **Superintendent of Alipore Women Correctional Home** and the **CI, Kolkata Lockup** for their information and necessary action.
