The accused Gokul Mondal (36 years) is not produced before this Court from JC through VCS due to technical fault.

Today is fixed for hearing of the bail application filed on behalf of the accused on 19.02.2026. The same is taken up for hearing in presence of both sides.

Ld. Advocate for the accused person has submitted that the accused is innocent and has been falsely implicated in this case. Ld. Advocate has further submitted that his client is in no way connected with the alleged offence and the accused is in custody for a considerable period. Thus, he has prayed for bail of the accused person in any condition.

Ld. Special P.P. raised objection against the prayer for bail.

Heard the Ld. Advocate for the accused and the Ld. Special PP. Perused the CD, statement of the VG recorded u/Sec.183 BNSS and other materials in the case record.

This is a case u/Sec.10 of POCSO Act. From the statement of the VG as well as the mother of the VG u/Sec.183 BNSS it appears that there was no sexual penetration upon the VG but there was physical touch and contact by the elderly accused for which he undergone sufficient incarceration. Considering all the materials on record I am of the opinion that further detention of the accused would lead to no new disclosure of facts. Thus having considered the above facts and circumstances and the period of detention already suffered by the accused, I am inclined to allow the prayer for bail of the accused.

Accused Gokul Mondal may find *interim bail* on furnishing bail bond of Rs.10,000/- with two sureties of Rs.5,000/- each

subject to the satisfaction of Ld. CJM, Alipore and on condition that the accused shall not enter into the vicinity where the victim resides and shall not leave the jurisdiction of the Court without prior permission of the Court till further order and he shall execute a bond with an undertaking to be present in Court on every date of hearing and that the accused shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him / her from disclosing such facts to the Court or any police official or tamper with the evidence.

If on bail, fix **07.09.2026** for appearance and IO's report.
