Accused **Harekrishna @ Biplab Mondal** is produced from J/C through VCS.

Today is fixed for hearing of bail application. The same is taken up for hearing in presence of all sides.

Ld. Advocate for the accused person has submitted that the accused is innocent and has been falsely implicated in this case. Ld. Advocate has further submitted that his client is in no way connected with the alleged offence. Thus, he prayed for bail of the accused person in any condition.

Ld. Special P.P. raised objection against the prayer for bail.

Defacto complainant is also present and raised objection against the prayer for bail.

Heard both sides. Perused the CD, statement of the VG recorded u/Sec.183 BNSS and other materials in the case record including the medical examination report of the VG.

It transpires from the CD including the statement and medical examination report of the victim that there are sufficient incriminating materials against the accused showing his involvement in the commission of offence. Thus having considered the nature and gravity of the offence, I am not inclined to enlarge the accused person on bail.

Hence, the prayer for bail is rejected. Accused Harekrishna @ Biplab Mondal be remanded to J/C till the next date.

Accused persons namely Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya surrendered today before this Court and filed a petition along with fresh Vakalatnama praying for bail. They are taken into judicial custody.

A bail petition has been filed on behalf of the accused persons.

Ld. Advocate for the accused submitted that Charge Sheet has been submitted against the accused persons and summons were issued against the three accused persons. Thus he prays for bail.

Ld. Special P.P raised objection.

Heard both sides. Perused the materials in record.

Having considered the materials in CD and also considering that Charge Sheet has already been submitted and summons were issued against the present three accused persons, I am inclined to enlarge the accused persons on bail.

Accordingly, accused persons namely Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya may find bail of Rs. 3,000/-(rupees three thousand only) each with two sureties of Rs.1,500/- (rupees one thousand five hundred only) each subject to satisfaction of learned C.J.M Alipore with condition that the accused persons shall attend the Court on each and every date fixed i.d to J.C.

Fix **19-07-2025** for production of accused Harekrishna @ Biplab Mondal, appearance of accused Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya and consideration of charge.
