Accused Harekrishna @ Biplab @ Bikaram Mondal is produced before this Court from J/C through VCS.

Accused Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya on CB are present by filing hazira.

Today is fixed for consideration of charge.

Learned Special P.P-in-charge is present.

Learned Defence Counsel is also present.

Learned Special P.P-in-charge opens the case by describing the charges to be framed against the accused persons.

Perused the materials on record and C.D.

On perusal of the same, I find sufficient materials against the accused Harekrishna @ Biplab @ Bikaram Mondal under section 137(2)/140(3)/87/64(2)(m) of BNS and Sec. 6 of POCSO Act and against accused Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya under Sec. 137(2)/140(3)/3(5) BNS and Section 17 of the Protection of Children from Sexual Offences (POCSO) Act, 2012.

Charge is framed accordingly against the accused accused Harekrishna @ Biplab @ Bikaram Mondal under section 137(2)/140(3)/87/64(2)(m) of BNS and Sec. 6 of POCSO Act and against accused Raju Baidya, Sanjib Baidya and Madhumita Mondal Baidya under Sec. 137(2)/140(3)/3(5) BNS and Section 17 of the Protection of Children from Sexual Offences (POCSO) Act, 2012 on separate sheet of paper and the same is kept with the case record.

The contents of the charges is read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.

The identity of the victim girl is required to be kept confidential as per provisions of **Sec 33 (07) of POCSO Act, 2012** as well as **under the direction of the Hon'ble Supreme Court in Nipun Saxena Vs Union of India** and **the direction of the Hon'ble High Court, Calcutta in Bijoy @ Guddu Das Vs The State of West Bengal** and also in **Prabir Bhuian Alias Prabir Bhuinyan Vs The State of West Bengal**. So to prevent the disclosure of the identification of the said victim child, his / her name and address are not mentioned in the above said charge form.

Fix **25.08.2025** for production, appearance and evidence of victim child. ***IO of this case is directed to produce the victim child for evidence.***
