Today is fixed for further hearing of the application for visitation.

Petitioner files hazira.

None appears on behalf of the O.P / mother on repeated calls.

Learned Counsel appearing for the petitioner / father is present.

It appear that there is a direction of the Hon'ble High Court, Calcutta in **CO-1891 of 2024** passed on **04.08.2025** wherein the Hon'ble Court has requested this court to dispose the application for visitation as expeditiously as possible without granting any unnecessary adjournments to either of the parties.

In view of such solemn direction of the Hon'ble Court, the application for visitation is taken up for hearing.

Learned advocate for the petitioner prayed for interim visitation of the minor daughter manifesting the grounds stating inter alia therein.

Heard the submission on behalf of the petitioner.

Perused the record.

It appears from the photocopy of the birth certificate of the minor namely Nila Rani Mondal that present petitioner is the father of the said child. Considering the fact that for holistic development and welfare of the minor and taking into account the fact that the petitioner being the father of the minor cannot be deprived of his right to meet and interact with the minor and taking into account of the solemn order of the Hon'ble Court passed in **CO No.1891 of 2024 on 04.08.2025**, this court is of the opinion that the petitioner / father must be allowed an order of interim visitation.

O R D E R E D

the prayer for interim visitation is hereby allowed.

The petitioner/father shall meet his daughter at the Office of District Legal Services Authority, Alipore, South 24 Pgs twice in a week i.e. on **Monday and Friday** from **3.00 PM to 5.00 PM**.

The respondent/mother is directed to produce her minor daughter for visiting his father/petitioner on the relevant dates and time.

Parties to direct the maintain proper decorum at the time of visitation.

Let a copy of this order be sent to the Secretary, District Legal Services Authority, Alipore for information and taking necessary action.

Since petitioner / father is present before this Court, the matter is otherwise ready for hearing and disposal.

As such let the matter be transferred to **Ld. Additional District Judge, 15th Court at Alipore, South 24 Parganas**, for hearing and disposal, along with all pending interlocutory applications, if any.

Fix **05.09.2026** for appearance of the parties before the Ld. Transferee Court.
