It appears from the record that these accused persons have been granted bail by this Court under section 482 B.N.S.S vide Order No. 04 dated 04.06.2025 in CMC Case No. 1784 of 2025. In view of the aforementioned order and considering the submission of both sides, I am inclined to release these accused persons on bail. Hence bail prayer of the aforementioned accused persons stands allowed.

Accordingly, accused persons namely **Hasan Mullick, Amanur Rahaman Mullick, Eajjaj Ali Mullick, Mijanur Rahaman Mullick** and **Sabir Mullick** may find bail of **Rs. 5,000/- (rupees five thousand only) each** with **two sureties of Rs. 2,500/- (rupees two thousand five hundred only) each** subject to satisfaction of learned C.J.M Alipore with condition that he shall co-operate with the I.O during investigation and shall appear before this Court on each and every date of hearing i.d to J.C till 08.07.2025.

If on bail to **25.11.2025** for appearance of accused and I.O's report.
