Learned advocate for the accused persons submitted that these accused persons have already been granted anticipatory bail by this Court in CMC Case No. 2863 of 2025. Today they surrendered before this Court and prayed for regular bail.

Learned Special P.P-in-Charge raised objection.

Perused the materials on record and the petition as well.

It appears from the record that these accused persons have been granted bail by this Court under section 482 B.N.S.S vide Order No. 03 dated 08.07.2025 in CMC Case No. 2863 of 2025. In view of the aforementioned order and considering the submission of both sides, I am inclined to release these accused persons on bail. Hence bail prayer of the aforementioned accused persons stands allowed.

Accordingly, accused persons namely **Anupam Sardar @Dinu Sardar** and **Subhash Kumar Singh @Subhash Singh** may find bail of **Rs. 3,000/- (rupees three thousand only) each** with **two sureties of Rs. 1,500/- (rupees one thousand five hundred only) each** subject to satisfaction of learned C.J.M Alipore with condition that the accused persons shall co-operate with the I.O during investigation and they shall also appear before this Court on each and every date of hearing i.d to J.C till 13.08.2025.

If on bail to **08.12.2025** for appearance of all accused persons and supply of copy.
