Accused Sk. Sharib Hussain @ Danish (22 years) is produced before this Court from J/C in person.

One bail application has been filed by the Ld. Advocate for accused. Ld. Advocate prays for time to move the application for bail. As such the bail prayer is kept in abeyance.

I.O of this case has made prayer for P.C of this accused till 01.03.2026 for the purpose of investigation. I.O. is present with C.D.

I have heard the IO as well as the Ld. Special PP. I have perused the materials as available in CD.

It is a case under section 4 of POCSO Act read with Sec.69 BNS, 2023. It appears from the PC prayer of the I.O that prayer of I.O for PC of the accused has been forwarded by superior officer. From the submission of prosecution it reveals that I.O requires PC of this accused for the purpose of verifying the statement of the accused and conducting his medico-legal examination for the purpose of investigation of the case. So, for the purpose of investigation the prayer of PC requires to be allowed and the other prayers of the I.O are also considered and allowed.

Accused Sk. Sharib Hussain @ Danish is remanded to police custody till **19.02.2026**. I.O is further directed to observe the guidelines of the Human Right Commission and direction of the Hon'ble Supreme Court regarding police custody of the said accused person. I.O is also directed to take all necessary steps for medical check-up of the accused at the regular intervals and not to make any kind of torture during P.C period.

Other prayers filed by the IO are considered and allowed.

The Professor & Head of Department, Forensic & State Medicine, Medical College & Hospital, Kolkata is requested to conduct the medico-legal examination upon the accused and send the report as early as possible.

Fix **19.02.2026** for production of the accused person from PC, hearing of bail application and I.O's report.
