Order No.03 Dt.28.07.2026

This is an application for anticipatory bail filed by petitioners namely 1. **Shyamali Mondal** 2. **Jhumpa Sarkar @ Rumpa**, 3. **Buro Sardar @ Mangal Sardar**, 4. **Sanjib Bhowmick**, 5. **Sangita Paik**, 6. **Sukla Paik**, 7. **Kalpana Roy**, 8. **China Shikari @ Titu Rani Shikari Bhowmick**, 9. **Amit Shikari**, 10. **Gopal Shikari**, 11. **Nepal Shikari** and 12. **Sima Das** u/s 438 Cr.P.C. / 482 BNSS apprehending arrest in connection with Kasba PS Case No. 299 dated 09.06.2026 under section 126(2)/118(1)/74/3(5) of BNS read with section 8 of POCSO Act. The anticipatory bail application of petitioners is taken up for hearing in presence of both sides.

Ld. Advocate for the accused / petitioners submits that no such application u/Sec.482 BNSS is neither pending nor rejected before any superior Court.

Ld. Advocate for the accused / petitioners has submitted that his clients are innocent and have falsely been implicated in this case. Ld. Advocate submits that his clients have complied with the notice u/Sec.35(3) of BNSS and met with the IO. Thus he prays for bail.

Ld. Special PP-in-Charge raised objection against the prayer for bail.

Heard the Ld. Advocate for the accused / petitioners and the Ld. Special PP-in-Charge. I have also perused the materials in CD.

Considering the materials available in CD and also considering the fact that the present petitioners / accused persons have complied with the notice u/Sec.35(3) of BNSS and met with the IO, I think that there is no need for custodial detention of the present accused / petitioners.

Accordingly, I am inclined to allow anticipatory bail of the accused / petitioners. In the event of arrest in connection with the above referred case accused/petitioners namely 1. **Shyamali Mondal** 2. **Jhumpa Sarkar @ Rumpa**, 3. **Buro Sardar @ Mangal Sardar**, 4. **Sanjib Bhowmick**, 5. **Sangita Paik**, 6. **Sukla Paik**, 7. **Kalpana Roy**, 8. **China Shikari @ Titu Rani Shikari Bhowmick**, 9. **Amit Shikari**, 10. **Gopal Shikari**, 11. **Nepal Shikari** and 12. **Sima Das** may find *bail* of Rs. 5,000/- (rupees five thousand only) each with two sureties of Rs. 2500/- (rupees two thousand and five hundred only) each to the satisfaction of arresting officer with condition that they shall cooperate with I.O during investigation and shall also comply all the requirements as enumerated under section 482 (2) BNSS and on condition that the accused / petitioners shall not enter into the jurisdiction where the victim resides till further order.

The Criminal Misc Case is thus disposed of.
