The record is put up by petition filed by the learned advocate Kaushik Chatterjee on behalf of the accused / petitioners 1. **Dr. Anindita Singh** and 2. **Ishaan Singh**.

By filing an application the accused / petitioners Dr. Anindita Singh and Ishaan Singh have surrendered before this Court today. They are taken into custody.

Received another application along with the Certified Copy of the Order of the Hon'ble High Court, Calcutta passed on 17.09.2025 in C.R.M. (A) **3281 of 2025** filed by learned advocate Kaushik Chatterjee and he sought for permission to furnish bail bond in respect of the aforementioned accused / petitioners as directed by the Hon'ble High Court.

Heard learned advocate for the accused / petitioners and the learned Special P.P-in-charge.

Perused the Certified Copy of the Order passed by the Hon'ble Court.

It appears from the said Order, the Hon'ble Court was pleased to pass an Order as follows:

“In the event of arrest, the petitioners shall be released on bail upon furnishing a bond of Rs.10,000/- each with two sureties of like amount each, one of whom must be local, to the satisfaction of the Arresting Officer and also be subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure, 1973 corresponding to Section 482(2) of the BNSS, 2023 and on further condition that the petitioners shall not threaten or intimidate witnesses, shall cooperate with investigation and the petitioner no. 2 shall meet the I.O. twice a week till submission of report in final form”.

Thus, having regard to the Order of the Hon'ble Court, Calcutta passed in C.R.M.(A) 3281 of 2025, accused / petitioners namely 1. **Dr. Anindita Singh** and 2. **Ishaan Singh** are entitled to be released on anticipatory bail.

In view of the Order of the Hon'ble High Court accused / petitioners namely 1. **Dr. Anindita Singh** and 2. **Ishaan Singh** are directed to furnish bail bond before the learned C.J.M, Alipore as register of sureties is maintained before the learned C.J.M, Alipore.

Learned C.J.M, Alipore is requested to allow accused / petitioners 1. **Dr. Anindita Singh** and 2. **Ishaan Singh** to furnish their bail bonds as directed by the Hon'ble Court.

Office is directed to release the accused persons / petitioners if bonds are accepted.

If on bail, to date i.e. **07.03.2026** for appearance of accused persons and IO's report.
