Learned Advocate for the accused submits that this accused has already been granted anticipatory bail by this Court u/Sec.482 BNSS in CMC No. 4053 of 2025. Today he voluntarily surrendered before this Court and prays for regular bail.

Learned Special PP-in-Charge left the matter to the discretion of the Court.

Perused the materials on record and the petition as well.

It appears from the record that this accused person has been granted bail by this Court u/Sec.482 BNSS vide Order No.4 dated 24.09.2025 in CMC No. 4053 of 2025. In view of the said order and considering the submission of both sides, I am inclined to release this accused on bail. Hence the bail prayer of the accused stands allowed.

Accordingly, accused **Anima Mondal** may find bail of **Rs.5,000/- (rupees five thousand only) with two sureties of Rs.2,500/- (rupees two thousand five hundred only) each** subject to the satisfaction of Ld. CJM, Alipore with condition that she shall cooperate with the IO during investigation of this case and the accused will appear before this Court on each and every date of hearing i.d. to J/C.

If on bail, to date i.e. **11.03.2026** for appearance of accused and IO's report.
