The case record is put up on the prayer of accused **Kalipada Mondal** who surrendered before the Court by filing a petition along with vakalatnama and prayed for bail.

He is taken into custody and remanded to J.C.

Heard both sides.

Learned advocate for the accused submitted that this accused person has already been granted anticipatory bail by this Court in CMC Case No. 5502 of 2024. Today he surrendered before this Court and prayed for regular bail.

Learned Special P.P-in-Charge raised objection.

Perused the materials on record and the petition as well.

It appears from the record that this accused has been granted bail by this Court under section 482 B.N.S.S vide Order No. 04 dated 03.01.2025 in CMC Case No. 5502 of 2024.

In view of the aforementioned order and considering the submission of both sides, I am inclined to release this accused on bail. Hence bail prayer of the aforementioned accused stands allowed.

Accordingly, accused **Kalipada Mondal** may find bail of **Rs. 5,000/- (rupees five thousands only)** with **two sureties of Rs. 2,500/- (rupees two thousand and five hundred only)** each subject to satisfaction of learned C.J.M Alipore with condition that the accused persons shall co-operate with the I.O during investigation of this case and he shall meet the I.O once in a week until further order. The accused is further

conditioned to appear before this Court on each and every date of hearing i.d to J.C till 03.03.2025.

If on bail to **20.02.2025** for appearance of accused Kalipada Mondal, production of accused Gopal Mondal and hearing of bail petition.
