Accused Abhijit Sardar @ Avi on interim bail is present by filing hazira.

Today is fixed for consideration of charge.

Learned Special P.P-in-charge and learned Defence Counsel are present.

At this stage a petition has been filed on behalf of accused person praying for confirmation of interim bail of accused on the ground stated therein.

Copy served to learned Special P.P.

Learned Special P.P raises no objection.

Heard both sides. Perused the petition as well as materials on record.

On consideration of the same, I find that there is no adverse report against this accused person. Under such circumstances, the petition filed on behalf of accused for confirmation of his A/I bail is allowed. Hence, A/I bail granted to the accused Abhijit Sardar @ Avi is hereby confirmed.

Now the case record is taken up for consideration of charge in presence of both sides.

Learned Special P.P-in-charge opens the case by describing the charges to be framed against the accused person.

Heard both sides. Perused the materials on record and C.D.

On perusal of the same, I find sufficient materials against accused Abhijit Sardar @ Avi under section 363/ 376 (3) of I.P.C and Sec 06 of the Protection of Children from Sexual Offences (POCSO) Act, 2012.

Charge is framed accordingly against accused Abhijit Sardar @ Avi under section 363/376 (3) of I.P.C and Sec 06 of the Protection of Children from Sexual Offences (POCSO) Act, 2012 on separate sheet of paper and the same is kept with the case record.

The contents of the charges are read over and explained to the accused person in Bengali to which he pleads not guilty and claims to be tried.

The identity of the victim girl is required to be kept confidential as per provisions of **Sec 33 (07) of POCSO Act, 2012** as well as **under the direction of the Hon'ble Supreme Court in Nipun Saxena Vs Union of India** and the **direction of the Hon'ble High Court, Calcutta in Bijoy @ Guddu Das Vs The State of West Bengal**. So to prevent the disclosure of the identification of the said victim girl, her name and address are not mentioned in the above said charge form.

Fix 05.03.2022 for appearance of accused and evidence of victim girl & informant.

Issue summons accordingly.
