The accused Pratap Mishra (50 years) is brought under arrest and produced before this Court along with relevant documents. He is taken into custody.

Ld. Advocate has entered appearance on behalf of the accused by filing a fresh Vakalatnama. Let it be kept with the record. One bail application has also been filed. Ld. Advocate prays for time to move the application for bail. Bail prayer is kept in abeyance.

I.O of this case has made prayer for P.C of this accused for seven days to unearth the actual motive behind the crime for the purpose of investigation of the case.

Heard learned Special P.P as well as the I.O. Perused the prayer.

It is a case u/Sec.115(2)/118(1)/117(2)/109/316(2)/82(1)/351(2)/3(5) BNS & 10/12 of the Protection of Children from Sexual Offence Act, 2012. It appears from the PC prayer of the I.O that prayer of I.O for PC of the accused has been forwarded by the Superior Officer. Thus having considered the submissions of the prosecution to unearth the truth, I am inclined to allow the prayer for P/C for the purpose of investigation of the case. So, for the purpose of investigation the prayer of PC is allowed.

Accused Pratap Mishra is remanded to police custody till **01.12.2025**.

I.O is further directed to observe the guidelines of the Human Right Commission and direction of the Hon'ble Supreme Court regarding police custody of the said accused person. I.O is also directed to take all necessary steps for medical check-up of the accused at the regular intervals and not to make any kind of torture during P.C period.

IO of this case has prayed for adding Sections 64/62/61(2) of BNS r/w 06/18 of POCSO Act along with the original sections of law.

I have heard the IO. I have perused the materials in CD including the medical documents of the victim girl.

On due consideration prayer of the IO for adding Sections 64/62/61(2) of BNS r/w 06/18 of POCSO Act is allowed.

Let sections 64/62/61(2) of BNS r/w 06/18 of POCSO Act be added in this case along with the existing sections of law.
