Two accused persons namely 1. Pratap Mishra (50 years) and 2. Mithu Das @ Mithu Kundu (48 years) are not produced before this Court from JC through VCS due to non-availability of internet service.

Ld. Advocate has prayed for time to move the bail application of accused Pratap Mishra. Accordingly prayer for bail of accused Pratap Mishra is kept in abeyance.

Bail application of accused Mithu Das @ Mithu Kundu is taken up for hearing in presence of all sides.

Ld. Advocate for the accused person has submitted that the accused is innocent and has been falsely implicated in this case. Ld. Advocate has further submitted that his client is in no way connected with the alleged offence and she is in custody for a considerable period and charge sheet has already been submitted in this case after completion of investigation. Thus, he prayed for bail of the female accused person in any condition.

Ld. Special P.P. raised objection against the prayer for bail.

Defacto complainant is personally present and has raised objection against the prayer for bail.

Heard the Ld. Advocate for the accused, Ld. Special PP and the defacto complainant. Perused the CD, statement of the VG recorded u/Sec.183 BNSS and other materials in the case record.

Considering the fact that Charge Sheet has already been submitted in this case after completion of investigation and considering the statement of the VG recorded u/Sec.183 BNSS as well as the period of detention already suffered by the accused, I am inclined to enlarge the female accused Mithu Das @ Mithu Kundu on bail.

Accused **Mithu Das @ Mithu Kundu** may find interim bail on furnishing bail bond of Rs.5000/- with two sureties of Rs.2500/- each subject to the satisfaction of Ld. CJM, Alipore.

Accused Pratap Mishra be remanded to J/C till the next date.

To **02.02.2026** for production, appearance, consideration of charge and hearing of bail application of accused Pratap Mishra.
