Two accused persons namely Somnath Das and Uttam Biswas are produced from Presidency Correctional Home through V.C.S.

Three accused persons namely Abhirup Nandy @Jishu, Rabi Pramanik @Abir and Prasenjit Banerjee @Jay are produced from Baruipur Central Correctional Home through V.C.S.

Four female accused persons namely Arpita Das @ Putul, Laxmi Sarkar @Payel, Arpita Majumder and Ruksana Bibi @Tuktuki are produced from Alipore Women Correctional Home in persons.

Bail petitions have been filed on behalf of accused Rabi Pramanik @Abir and Laxmi Sarkar @Payel along with fresh vokatnama.

None moves for bail prayer of accused Rabi Pramanik @Abir and accordingly the said petition is rejected.

Heard both sides on bail prayer of accused Laxmi Sarkar @Payel.

Considering the gravity of offence and materials on record, bail prayer of accused Laxmi Sarkar @Payel stands rejected.

Learned lawyer for accused Ruksana Bibi @ Tuktuki files a petition u/s 227 Cr.P.C praying for discharge of accused on the ground stated therein. Let the said petition be kept with the case record.

Today is fixed for consideration of charge.

Learned lawyers for all nine accused persons except learned Defence Counsels for accused Uttam Biswas and Abhirup Nandy @Jishu are present.

Learned Defence Counsels for accused Uttam Biswas and Abhirup Nandy @Jishu are absent on repeated calls.

Accused Uttam Biswas and Abhirul Nandy who are produced through V.C.S have been asked for taking assistance of learned lawyer from District Legal Services Authority but they have refused to take assistance of learned lawyer from District Legal Services Authority and submitted that they had appointed their private lawyers who would be present on the next date of hearing.

Accordingly, hearing on the point of charge is adjourned due to absence of learned advocates for accused Uttam Biswas and Abhirul Nandy.

Both the accused persons are directed to ask their respective learned lawyers to remain present on the next date of hearing positively.

All nine accused persons are remanded to J.C.

Fix 01.04.2021 for production of all nine accused, appearance of Defence lawyer for Uttam Biswas and Abhirup Nandy @ Jishu, consideration of charge and hearing of discharge prayer of accused Ruksana Bibi @ Tuktuki.
