Accordingly, the case is adjourned today due to absence of learned lawyers for accused persons namely Uttam Biswas, Somnath Das, Laxmi Sarkar @Payel and Arpita Majumder.

Accused persons are remanded to J.C till next date.

Fix 09.07.2021 for production of all nine accused persons, charge hearing, further hearing of bail application of accused Prasenjit Banerjee Arpita Das and Uttam Biswas and also for hearing of the discharge prayer of accused Ruksana Bibi @Tuktuki.

The Superintendent of Alipore Women Correctional Home is directed to produce all the four female accused persons namely Arpita Das @Putul, Laxmi Sarkar @Payel, Arpita Majumder and Ruksana Bibi @Tuktuki on the date fixed.
