Witness is examined as PW2 and cross examination in full then discharged.

Fix 05/06/23 for production and evidence of major VG.

At this state , on behalf of the minor victim girls file a petition , praying for allowing adequate interim compensation from the Victim Compensation Fund.

Heard both sides. Perused the same and considered.

It appears from case record that the accused persons of this case are forcefully committed aggravated penetrative sexual assault on the Victim Girls. The Victim Girls are already been examined as PW1(CSW2) and PW2 (CSW12) in this case.Considering the testimony of PW1 and 2 (V. G) and other facts and circumstances of this case and the future needs of the victim girls, I think that they need some interim monetary compensation for their rehabilitation , studies as well as repatriation in mainstream of the society.

In view of order passed by the Hon'ble Supreme Court of India in **Nipun Saxena Vs Union of India and the direction of the Hon'ble High Court , Calcutta in Bijoy @ Guddu Das Vs The State of West Bengal and also in view of provision contained under Clause 9 & 12 of NALSA'S Compensation Scheme for Women Victims / Survivors of Saxual Assault / Other Crimes , 2018** it is hereby directed that an amount Rs. 50,000/- (Rupees fifty thousand only)shall be paid to the victim girls each , from the Women Victim Compensation Fund / Victim Compensation Fund of the Government of West Bengal as interim relief for her rehabilitation and maintenance.

The Secretary , District Legal Services Authority , Alipore shall take necessary steps for payment on interim compensation to the victim girl from Women Victim Compensation Fund / Victim Compensation Fund of the Government of West Bengal at earliest.

Let a copy of order be sent to the Secretary , District Legal Services Authority, Alipore by name in a close envelope with name and address of the victim girl for payment of interim compensation and necessary compliance.
