Learned Special PP-in-Charge left the matter to the discretion of the Court.

Perused the materials on record and the petition as well.

It appears from the record that this accused person has been granted bail by this Court u/Sec.482 BNSS vide Order No.4 dated 03.01.2025 in CMC No. 5477 of 2024. In view of the said order and considering the submission of both sides, I am inclined to release this accused on bail. Hence the bail prayer of the accused stands allowed.

Accordingly, accused **Sk. Intajul** may find bail of **Rs.5,000/- (rupees five thousand only) with two sureties of Rs.2,500/- (rupees two thousand five hundred only) each** subject to the satisfaction of Ld. CJM, Alipore with condition that he shall cooperate with the IO during investigation of this case and the accused will appear before this Court on each and every date of hearing i.d. to J/C till 20.01.2025.

If on bail, to **22.05.2025** for appearance of accused and IO's report.
