The concerned SHO/Incharge of summoning staff shall also ensure the presence of all prosecution witnesses on the next date of hearing, failing which the defaulting officer(s) shall remain personally present before this Court to explain the

lapse.

A copy of this order be sent to the DCP, Panchkula for information and necessary compliance.

Till then, accused Gurdit is remanded to judicial custody and be produced before the Court on the date fixed.
