

Further chief of P.W4 Tarak Roy resumes on 03.11.2025

Today all the six accused persons namely Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana are produced before the Court on virtual mode.

I reside at Rajarhat, Pragatimaidan Kolkata 700007.

I know the local inhabitation of our locality like Ganesh, Kartick, Laltu, Beji and others.

I used to go to Hatgachia occasionally. I used to meet Tarak Mondal at Hatgachia for taking wine.

Tarak Mondal is no more today.

In December when I along with others i.e. (Beji, Shyamal, Ganesh) playing card at the garage of corporation at Dhapa then I saw Tarak Mondal was coming with a limping condition. Then Tarak stated us to bring him at hospital for treatment.

I told Ganesh to take the bike of Shyamal. Then Ganesh and Pacha took Tarak Mondal at the bike. Tarak was sitting between them. Ganesh was driving the bike.

In another bike I, Shyamal and Beji went to the hospital along with the other bike. Shyamal was riding our bike.

Then Tarak told us to go to the hospital through Bangabir Math avoiding Madhpukur Math. The two bikes were going through Pagladanga Bridge. At one side of Bangabir Math two persons pushed Ganesh from the bike. I did not see the persons who pushed Ganesh because it was dark outside. Seeing the same I and Beji fled away towards Dhapa from our bike. After about half an hour I and Beji and about 40 other persons went to Bangabir Math where police already came. I saw that blood was scattered on the ground . I also saw that Tarak Mondal was lying on the ground with cut injuries. Thereafter I went back to my house. Police interrogated me during investigation.

(The witness is declared "Hostile" by the Prosecution)

Cross examination by the Prosecution:-

I stated to the police that I work as a plastic scrap dealer. I have been residing here since my childhood and I know many persons in our area such as Ganesh Dey, Biju Gure @ Beji, Gopal Das. Many persons of Hatgachia area also come to Dhibi and participate with us for gossiping and playing cards such as Tarak Mondal, Habul Mondal, Swapan Mondal, Pradip Mondal, Sanjoy Mondal and many others. I also go to Hatgachia, for gossiping with my friends. Tarak Mondal is my good friend. He does business of construction and supplying the construction material in Hatgachia areas. He occasionally asks for help from me in his business. As I also go to Hatgachia, for gossiping with my friends I know other persons of Hatgachia namely Chotu Mondal, Jhulan, Milan Jana, Bhajo Mondal, Anil Mondal @Ani, Bhulu Maity, Biswajit Das Nibas, Thantu, Nepal and many others. I have no fixed time for work.

I also stated to the police that in the leisure time I go to in a local place which is locally known as Dhibi in front of Corporation garage in our area for gossiping or playing cards with my friends. Today (31.12.18) in the morning I was playing card with my friend namely Beji, Md. Shyamal Molla, Ganesh Dey at the Dhibi near Corporation Garage. At about 10.30/10.45 hrs I noticed that my friend Tarak Mondal of Hatgachia came in limping gait to Dhibi where we were playing cards. He was very scared and anxious. On asking Tarak told us that Bhajo Mondal, Bhulu Maity, Anil Mondal, Biswajit Das @ Nibas, Chotu Mondal and Milan Jana attacked on Swapan. Habul, Bhola Sardar and Tarak Mondal with Katari, Hansua, Nepala and other deadly sharp cutting weapons in the court

yard of Bhai Bhai Sangha Club and injured him. He also added that he somehow managed to escape from them but he got injury in his left leg by Anil with a Katari Then he requested us to remove him to N.R.S Hospital. Then Md. Shyamal Molla and Ganesh Dey both took out their motor cycles. Tarak Mondal sat on the bike of Ganesh and Gopal Das @Pacha sat behind Tarak Mondal. On the other bike Md. Shyamal Molla, I and Beji followed them. At the time of starting Tarak Mondal told that we should follow the Pagladanga Road so that we could go fast to NRS Hospital. Then we left for NRS Hospital through Pagladanga Road. The Pagladanga Road runs from South to north direction. We went from southern side to northern side. When we reached in front of 7, Pagladanga Road near Bangabir Club ground we saw Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana came from the opposite direction i.e. from northern side in very furious mood with deadly weapons like Katary, Hansua, Nepala, Bhojali etc in their hands. Suddenly they attacked on us so we could not pass by them so we stopped our bike. Then suddenly Bhajo knocked heavily on the bike of Ganesh Dey as a result Ganesh, Tarak and Gopal @ Pocha fell down along with the bike. Then Anil, Chottu, Bhajo, Bhulu, Nibas, Milan attacked Tarak Mondal and assaulted him brutally on that place. In the mean time Nibas attacked on Pacha and assaulted with a Napla on his forehead. Ganesh was also injured as they also attacked him. I, Shyamal Molla and Beji left our bike on the road and took shelter in a bush placed on the western side of the Pagladanga road from where I noticed that Anil, Bhajo and Nibas @ Biswajit were shouting towards us that "J SALA EGOBI TAKEI SES KORE DEBO". Pocha somehow escaped from their clutch and took shelter beside a house situated on the eastern side of the Pagladanga Road beside Bangabir gound, Ganesh also took shelter near a bush on the eastern side of the Pagladanga road. Tarak could not escape from that place and all of them attacked on him. Milan was carrying a Hasua, Bhojo a dagger, Nibas had a Napala, Bhulu had a long Katari. Anil was holding another Katari and Chotu carried another Nepala. At that time Bhajo was shouting that "SALA EAKBAR PALIYE ESACHE, OKE JANE MERE DE". Then they recklessly assaulted Tarak Mondal as a result he got severe bleeding injury. Thereafter they fled away towards northern side along Pagladanga Road. Then I, Beji, Ganesh, Md. Shyamal Molla and Pocha came out from the hide out from where we noticed all the incident and came near to Tarak Mondal. Tarak was lying in pool of blood beside the road and some local person also gathered there. After some time police came to the spot and removed Tarak Mondal to the Hospital. Habul, Bholu, Nepal and some other persons also came to Pagladanga Road later. I, Pocha, Shyamal and Ganesh Dey also went to NRS Hospital where Pocha and Ganesh were treated. I came to know at NRS Hospital that Tarak Mondal was declared as brought dead.

Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana are present in the Court through virtual mode. I know them but I do not know whose name is which.

Not a fact that I stated falsely that at one side of Bangabir Math two persons pushed Ganesh from the bike and I did not see the persons who pushed Ganesh because it was dark outside.

I heard that the accused persons namely Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana were present at the time of incident at Bangabir Math.

Not a fact that I stated to the police that I saw the accused persons namely Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana committed the said incident.

The exhibit 3/14, exhibit 3/15 and exhibit 3/16 (three photographs of Tarak Mondal) were shown to the witness and the witness stated that the same the photographs of Tarak Mondal.

Not a fact that I am deposing falsely to save that the six accused persons namely Bhajo Mondal, Anil Mondal, Bhulu Maity, Chottu Mondal, Biswajit Das @ Nibas and Milan Jana are produced before the Court on virtual mode.

Not a fact that I am deposing falsely.

Cross-examination by the accuseds Bhulu Maity, Biswajit Das @ Nibas and Milan Jana:-

The lanes coming from Pagrladanga raod are from different name.

I did not state to the police that I used to go to Hatgachia occasionally and I used to meet Tarak Mondal at Hatgachia for taking wine.

I did not state to the police that I was playing cards along with others on the date of incident.

Not a fact that I did not see Tarak Mondal was coming with a linkping condition. Then Tarak did not state us to bring him at hospital for treatment. I did not tell Ganesh to take the bike of Shyamal. Then Ganesh and Pacha did not take Tarak Mondal at the bike. Tarak was not sitting between them. Ganesh was not driving the bike. In another bike I, Shyamal and Beji did not go to the hospital along with the other bike. Shyamal was not riding our bike.

Not a fact that I was not present at the place of incident on the date of incident.
