

Order no. 31 dated 05.11.2022

Today is fixed for ER/appearance.

No ER of WA is received against accused Habib Gazi.

Accused namely Sarafat Ali Laskar surrenders today by filing fresh vokalatnama along with one bail petition. The accused is taken into custody and remanded J.C.

The bail petition is taken up for hearing.

Ld. P.P. in charge is present. He raises objection against the bail petition.

Heard Ld. PP in charge as well as Ld. Advocate for the accused.

It appears that long before W/A was issued against this accused.

Considering nature of allegation against this accused, his overall conduct as reflected in the order sheet, present stage of this case and his voluntary surrender, the accused are released of interim bail of Rs. 1000/- with one surety each, other than previous surety, on condition to appear before this Court on each and every date of hearing henceforth subject to satisfaction of Ld. ACJM, Diamond Harbour id J.C. till date.

Recall W/A against this accused.

If on interim bail to 07.02.2023 for appearance.

Let a copy of this order sheet be sent to Ld. A.C.J.M, Diamond Harbour for taking necessary action to release the accused on acceptance of bail bond.

Accused Sabir Ali, Abdul Wahab Laskar are present by filing hazira. One time petition is filed for accused Sawkat. Heard. Prayer for time is rejected as WPA is pending against him.

From the record it appears that charge sheet was submitted in this case against 8 accused persons and out of said accused persons the case was committed against 6 persons ie. Sarafat Ali, Sabir Ali, Md. Nazim Kha, Abdul Wahab, Habib Gazi @ Nur Islam SK, Sahajan and case was filed for present against two accused persons namely Sawkat SK and Halim Gazi, by order passed by Ld. ACJM, Diamond Harbour.

Subsequently , the case was filed for present against accused order passed by Ld. Sessions Judge on 23.08.13 the case was filed for present against accused Md. Sahajan @ Munna.

Thereafter by order dated 08.02.18, 07.05.18, 19.07.18 charge was framed in this case against rest 5 accused persons namely Sarafat Ali,. Sabir Ali, Md. Nazim Khan, Habib Gazi @ Nur Islam SK and Abdul Wahab.
