I lodged complaint against Tapas Mistry to Magrahat PS.

He is present in court now (identified).

He was friend of my husband Balaram Mondal.

Avash Mistry is his son. He used to have conversation with my daughter Bidisha Mondal over phone.

On 24.06.18 Avash Mistry made a phone call to me. He wanted to talk with my daughter. But I along with my husband went to my father's abode on that day so I told Avash to make call to my daughter's phone.

Then she was in house of my brother in law (bhasur) Rabiram Mondal whose house is just beside our house.

He accordingly made phone call and he had conversation with my daughter.

When Avash made phone call to my daughter she came to our house and talked with him. After that she went to house of my brother in law and started crying.

I do not know exactly what conversation they had.

Then my brother in law and sister in law both asked my daughter why she was crying. She told them that Avash and his parents abused her in filthy languages and also misbehave with her because she talks with Avash.

About half and hour to one hour she stayed in house of my brother in law and thereafter she returned to my room and committed suicide by hanging herself with my saree.

We returned home about 20.00 hours and then we found my daughter in such condition.

Avash is facing trial in Juvenile court.

This is my hand writing and my signature.

I lodged complaint to police.

The complaint is marked as exhibit 1.

Cross examination

I read up to class IX.

Sandhya Rani Mondal is my sister in law. Papiya Mondal is her son's wife.

Debdas Mondal is her son. Shubhankar is her another son and Shibani Mondal is his wife. They were in their own house on the date of incident.

Arijit Biswas is friend of Avash. My daughter told it to me.

I do not know Raj Naskar.

I had only daughter.

It is fact on the date of incident in the evening my daughter went to house of Sandhya Rani Mondal because my husband and myself went to my father's house.

It is fact we used to visit house of accused and they also used to visit our house.

It is fact we went on tour also.

It is fact we used to love children of accused Tapash Mistry.

It is not a fact this accused used to love my daughter as his own child.

I made complaint to PS on 29.07.2018 and incident took place on 24.06.2018.

That delay is not explained in my written complaint.

I was not in mental state to lodge complaint immediately (vol).

Before 29.07.18 we did not go to police station or anywhere to file any complaint.

Other than filing complaint I had no conversation with police.

My daughter left no suicide note.

I cannot say, as I was not on the spot, if Avash made phone call to my daughter or my daughter phoned him.

It is not a fact it is my suspicion only that Avash and his parents abused my daughter and misbehave with her over phone on the date of incident.

I handed over my daughter's phone to police.

It is not a fact I did not mention it to my complaint that my brother in law and sister in law both asked my daughter why she was crying and she told them that Avash and his parents abused her in filthy languages and also misbehave with her because she talks with Avash and that about half and hour to one hour she stayed in house of my brother in law and thereafter she returned to my room and committed suicide by hanging herself with my saree and that on 24.06.18 Avash

Mistry made a phone call to me and he wanted to talk with my daughter and but I along with my husband went to my father's abode on that day so I told Avash to make call to my daughter's phone.

It is not a fact on the date of incident this accused person did not make any phone call to my daughter nor they misbehave with her or abused her.

It is not a fact my daughter had love affair with Avash.

It is not a fact we scolded our daughter as she was remaining engage with Avash over phone and was not studying for which she committed suicide.

It is not a fact I made false allegation against this accused person.

It is not a fact I have adduced false evidence.
