Accused persons namely (1) Makaram Mallick and (2) Sajahan Gazi are produced from J.C.

Three accused persons namely Mofijuddin Paik, Soumen Halder and Kurban Halder on bail are preset by filing hazira.

2 (two) accused persons namely Kamal Hossain Molla and Ashidul Molla are absent by petition and pray for time. Prayer for time is considered and allowed.

5 (five) accused persons namely Kamal Hossen Molla, Abusama Mir, Mor Selim Laskar, Ejanur Gazi and Inul Ghorami are absent without step. Accordingly the sureties of those absentee accused persons are directed to produce them before this court on the next date positively.

Today is fixed for hearing the bail petition of custody accused person namely Makaram Mallick. Another bail petition is filed on behalf of another custody person namely Sajahan Gazi along with fresh vokalatnama on the ground stated therein.

Both the bail petitions are taken up for hearing. Heard the Ld. Counsels for both sides. Ld. Defence counsels pray for bail for the accused persons under any terms and conditions considering the period of their detention.

Ld. P.P.-in-charge did not raise any material objection against the bail applications and prays for passing necessary order as the Ld. Court may deem fit and proper.

Heard both sides. Perused the materials on record. Considered.

Carefully perused the case record. From the case record it is found that the above named accused persons were on bail and due to non taking step W/A were issued against them from the court of Ld. A.C.J.M., Diamond Harbour on 01.11.2023. These accused persons are brought under arrest on 20.06.2024 and 22.05.2024 respectively and since then they are in custody. This is a case U/s.399/402 I.P.C. Considering the above facts and circumstances and the period of their detention the bail prayers are allowed.

Accused (1) Mokaram Mallick, S/O. Apsar Mallick of Village – Nilambarpur, P.S. Mandir Bazar, South 24-Parganas and (2) Sajahan Gazi, S/O. Samsul Haque Gazi of Village – Baharu Hasimpur, P.S. Joynagar, South 24-Parganas may find interim bail of Rs.2,000/- each with one registered surety of like amount on condition to appear before this court on each and every date henceforth, subject to the satisfaction of the Ld. A.C.J.M., Diamond Harbour till 03.09.2024.

After being satisfied with the bail bond, Ld. A.C.J.M., Diamond Harbour shall issue release order in favour of the accused.

To 03.09.2024 for appearance if on bail.

Let a copy of this order be sent to the Ld. A.C.J.M., Diamond Harbour forthwith for information and taking necessary action.
