Today is fixed for production of accused persons namely Pintu Mondal and Sampa Ghora from JC through VC, hearing of bail petitions filed for both accused persons on 17.05.2025 and 16.05.2025 respectively and IO's report.

Both the accused persons namely Pintu Mondal and Sampa Ghora are not produced from JC through VC and they are represented separately by their Ld. Advocates.

Ld. Spl. PP in charge namely Smt. Haimabati Sinha Barma files hazira for the State along with hazira of DC.

SR of notice received duly served upon DC.

CD is produced.

The case record is kept pass over on prayer of prosecution.

Both sides are present.

The case record is taken up for hearing of bail petitions filed for accused persons namely Pintu Mondal and Shampa Ghora.

At the very outset, Ld. Defence Counsels submit that no bail petition in respect of these accused persons in connection with this case is pending or rejected by any upper forum. It is submitted that the accused Pintu Mondal is in J/C since 10.04.2025 and accused Shampa Ghora is in JC since 21.04.2025. Ld. Counsels submit that VG is 14 years old and the scribe of the complaint is from Diamond Harbour. The complaint does not disclose the date when VG told the incident to her mother. The instant case has been lodged falsely against the accused persons. It transpires that on 28.03.2025 VG was married with Pintu Mondal, but accused Shampa Ghora was not present there. Ld. Counsels further adds that the ground of arrests has not been communicated in writing to accused persons. Delay in lodging FIR is not mentioned. Hence, is the prayer for bail of the accused persons.

Ld. Spl. P.P. in-charge opposes the bail petition and submits that V.G. is minor and the female accused is the neighbour of VG. The male accused is the prime accused and the female accused has aided in the commission of crime. So, the female accused has abetted the crime. The ground of arrest has been duly communicated to the accused person as reflects in CD. The delay in lodging the FIR has also been duly explained in the FIR. It is further submitted that the medical report of VG goes to show that she is 5 to 6 weeks pregnant and IO has already prayed for DNA test.

Considering the materials on record as well as in CD, including the statements of VG and DC, it is found that there are sufficient materials against these accused persons. Also the investigation is still going on.

As such considering all aspects this Court at this stage is not inclined to release the accused persons on bail.

Accordingly, bail petitions filed for accused persons namely Pintu Mondal and Shampa Ghora are rejected.

Return the C.D.

Fix 03.06.2025 for production of accused persons namely Pintu Mondal and Shampa Ghora from JC through VC and IO's report.

Next date be intimated to the Controller, Diamond Harbour Sub-Correctional Home regarding production of accused through VC.
