“ 1. It appears that in the earlier order of this Court dated 30.01.2026 in the cause title it is written as ‘WPA’ instead of ‘CO’.

2. In the said order ‘WPA’ be deleted and ‘CO’ be noted.

3. Let this order be read along with order dated 30.01.2026.

4. The order dated 30.01.2026 is modified accordingly.

5. Copies of order-sheets of the trial Court has been placed before this Court by the opposite parties.

6. It appears that the record was transferred from the Civil Court to the Commercial Court vide an order dated 05.07.2019. The record was received by the Judge, Commercial Court on 30th July, 2019.

7. It is in between this period that is on 15.07.2019 the learned counsel for the petitioner contends that the suit was dismissed for default.

8. It is further brought to the notice of this Court that the summons served upon the petitioner is dated 15.07.2019 whereas the copies of ordersheets do not show any order dated 15.07.2019.

9. Considering the said submissions, let the record of Money Suit 14 of 2019 be called for at once from the learned Commercial Court at Alipore.

10. Matter be listed for further hearing and necessary orders on 24th March, 2026.”
