Received the copy of order of the Hon'ble High Court being No. **FAT No. 204 of 2024** with CAN no. 1 of 2024 and CAN No. 2 of 2024 dated 10.09.2024 through Hon'ble High Court's Memo no. 1124 F dated 23.04.25. I carefully perused the order of the Hon'ble Court.

In the said order the Hon'ble High Court has been pleased to observe as follows:-

“.....Accordingly, we direct that the respondent no. 1 will make an application under rule 2.2.2 of the said Manual to the appellant by 04.10.2024. The appellant will verify that such application is according to the above rule.

The said respondent will advertise such application in three daily newspapers having wide circulation in West Bengal, namely the Times of India (English), the Ananda Bazar Patrika (Bengali) and the Sanmarg (Hindi), within ten days of making the application.

The appellant will wait for two weeks thereafter for an order from a court or a competent authority restraining such transfer, failing which they shall effect change of authorized signatory/signatories as per application made by the respondent no. 1.

The appeal and the connected applications are thus disposed of.

The application for judgement upon admission before the learned trial court shall be treated as not disposed of. An appropriate application may be made before the learned trial court for recording compliance of this order and to pass any other necessary order....”.

From the materials on record it appears that on 07.11.2024 , the copy of order of the Hon’ble Court , as referred above, has already been filed before this court by the Plaintiff and an application being I.A.No.04/2025 has also been filed on behalf of the plaintiff on 05.03.25 for recording compliance of the direction of the Hon’ble Court.
