*The Plaintiff and the Defendant are directed to pay the initial fees of Rs. 5,000/- only by each party directly to the Ld. Commissioner and file the respective acknowledgements in original on **20.06.2023 at 11.00 a.m.** and immediately thereafter, the Writ of the Commissioner will be issued.*

The fees of the Ld. Advocate Commissioner is fixed @ Rs.4,500/- only per day including the expenses of her steno-typist and others. The Ld. Advocate Commissioner fees in respect of PW be borne by the Plaintiff and the Defendant will bear the Ld. Advocate Commissioner fees in respect of DW.

The Ld. Advocates on behalf of both sides shall also serve the copies of their pleadings alongwith relevant documents positively upon the Ld. Advocate Commissioner in the meantime.

Both sides are directed to take steps for bringing witnesses at schedule date and hour as fixed by the Commissioner.

The Ld. Commissioner has liberty to mention the matter if the Commissioner needs any clarification.

The Ld. Advocate Commissioner is further requested to remain present on the day of recording the evidence and assist this Court in completing the oral evidence of the parties in terms of the Commercial Courts Act, 2015.

Bench Clerk is directed to put the case record before the Ld. Commissioner and to assist him during evidence.
