Today is fixed for consideration of show cause petition filed by the plaintiff on 15.12.2025 and for further order .

Record is taken up for consideration of show cause filed by the plaintiff on 15.12.2025.

At this stage, Ld. Advocate appearing on behalf of the plaintiff 'not pressed' the said show cause filed on behalf of the plaintiff on 15.12.2025. Accordingly, the show cause filed by the plaintiff on 15.12.2025 is rejected being 'not pressed'.

Today another show cause petition is filed by the plaintiff. The said show cause is taken up for consideration.

Heard both sides.

Perused the instant show cause filed today by the plaintiff and other materials on record. Ld Advocate on behalf of the plaintiff submitted that there is no intentional latches on behalf of the plaintiff and the plaintiff is willing to proceed with the instant Money Suit.

Ld Advocate on behalf of the defendant raised strong objection and submitted that the conduct of the plaintiff, as it appears from the materials on record, is not at all satisfactory.

From the materials on record it appears that on previous occasion also vide order no. 16 dated 05.12.25 this Court show caused the plaintiff and the plaintiff filed show cause on 21.03.2025. The said show cause filed by the plaintiff on 21.03.25 was accepted by this Court vide order no.18

dated 21.03.25. Thereafter again vide order no. 27 dated 04.12.25, considering the conduct of the plaintiff, this Court passed the order directing the plaintiff to show cause as to why the instant suit shall not be dismissed. Today the plaintiff filed the show cause. However, the cause shown by the plaintiff in the instant show is found sufficient. Moreso, as the plaintiff intends to proceed with the instant suit , I am inclined to allow the plaintiff a last and special chance to proceed with the instant suit. Hence, for ends of justice show cause filed by the plaintiff is hereby accepted.

The show cause petition filed by the plaintiff is thus disposed off.
