If a settlement agreeable to the Parties is reached, the terms shall be recorded by the Ld Mediator and signed by the parties/their counsel and returned to this Court for further appropriate orders.

If no settlement is reached, neither the parties, Ld. Advocates, nor the Ld Mediator may disclose to this Court anything that was discussed at the mediation.

Having regard to the nature of the case, the fees of the Ld Mediator be fixed at a consolidated amount of Rs.-----, in terms of Rule 26A(2) of the existing Mediation Rules, as amended, on settlement of the case through mediation.

Let the copy of this order along with photocopy of the cause title of the plaint be sent to Mediation and Conciliation Committee, High Court at Calcutta for necessary consideration.
