COMMITMENT ORDER.

1. S.H.O. Police Station Sadar Malout has sent up the accused as described in detail here in above to face the trial under sections 137(2), 96 BNS.

2. Brief facts of the case are that on 23.08.2024 ASI Jaskaran Singh No. 114/SMS was present at police station where complainant Kala Singh along with his brother Balvir Singh came present and got recorded his statement to the effect that he is labourer and he is having three daughters and one son. His elder daughter namely Arshdeep Kaur is aged about 17 years, then his second daughter namely Amandeep Kaur is aged about 16 years and his third son namely Anmol Singh is aged about 14 years and younger daughter namely Jasdeep Kaur is aged about 12 years. His daughter Amandeep Kaur is studying in +2 standard in Government Senior Secondary School, Malout and in routine on 13.08.2024 she went to school but did not return back to home. Complainant searched his daughter Amandeep Kaur at his relative and near places. On 15.08.2024 complainant came to know that one of his co-villager namely Jashandeep Singh @ Jashan son of Baljinder Singh fled away with his daughter on the pretext of marriage. Due to family reputation, complainant kept quiet, but now his daughter came back to house, so he came to police station to record his statement. On this complaint of complainant, present case was registered. Investigation was initiated. Site plan was prepared. Accused Jashandeep Singh @ Jashan was arrested. On 24.08.2024 complainant and his wife produced prosecutrix before the IO. Medical examination of accused was got done. During investigation statement of prosecutrix was got recorded from Ld. Illaqa Magistrate under Section 183 BNSS (164 Cr.PC). Other investigation formalities were carried out. Now after

completion of other necessary formalities of the investigation, challan under sections 137(2), 96 BNS was prepared and presented against the above mentioned accused in the Court.

3. From the scrutiny of papers, prima facie case under section 137(2), 96 BNS is found to have been made out against the accused persons. The offence u/s 96 BNS is exclusively triable by the Ld. Court of Sessions. Hence, the present case is committed to the Court of Ld. Sessions Judge, Sri Muktsar Sahib for 20.02.2025 and accused Jashandeep Singh @ Jashan is in custody, so jail authorities are directed to produce the accused before the Court of Learned District & Sessions Judge, Sri Muktsar Sahib on 20.02.2025 at 10:00 A.M. sharp. Ahlmad is directed to send the file complete in all respect, to the Court of Ld. Sessions Judge, Sri Muktsar Sahib well before the date fixed. Intimation regarding the commitment of the case be given to the Public Prosecutor.
