Record is put up today on the prayer of Ld. Advocate made on behalf of accused persons 1. Mithun Kumar Basak & 2. Ranjeet Kumar Biswas @ Ranjit Biswas with the xerox copy of order dated 19.06.2024 of the Hon'ble Court passed in C.R.M (NDPS) 938 of 2024, U/S 439 of Cr.P.C.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused persons 1. Mithun Kumar Basak & 2. Ranjeet Kumar Biswas @ Ranjit Biswas also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in C.R.M (NDPS) 938/2024 dated 19.06.2024.

The Ld. Advocate for the accused persons also authenticate the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date

I have perused the order of the Hon'ble Court passed in C.R.M (NDPS) 938/2024 dated 19.06.2024. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

"...Accordingly, , we direct that the petitioners, namely 1. Mithun Kumar Basak & 2. Ranjeet Kumar Biswas @ Ranjit Biswas, shall be released on bail upon furnishing a bond of Rs.25,000/- each, with two sureties of like amount each, one of whom must be local, to the satisfaction of the Learned Judge, Special Court under the NDPS Act, Raiganj, Uttar Dinajpur subject to condition that the present petitioners shall appear before the learned trial court on each date of substantive hearing subject to the provisions of Section 317 of the Code of Criminal Procedure, 1973. The petitioners shall remain within the jurisdiction of the trial court till conclusion of trial unless such conditions have been relaxed by the learned trial court.

The petitioners shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses and/or tamper with evidence and/or commit any cognizable offence in any manner whatsoever.

In the event the petitioners fail to adhere to any of the conditions stipulated above without any justifiable cause, the learned trial court shall be at liberty to cancel the petitioners' in accordance with law without reference to this court...."

In view of the aforesaid order of the Hon'ble Court, the accused persons **1. Mithun Kumar Basak & 2. Ranjeet Kumar Biswas @ Ranjit Biswas** are permitted to furnish bail bond of Rs.25,000/- with two sureties of like amount each, one of whom must be local to the **satisfaction of this court** regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.
