Record is put up today on the prayer of Ld. Advocate made on behalf of accused Ashutosh Sarkar @ Ashu along with the downloaded server copy of order dated 24.07.2024 of the Hon'ble Court passed in CRM (NDPS) 1138 of 2024, U/S 439 of Cr.P.C.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused Ashutosh Sarkar @ Ashu also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in CRM (NDPS) 1138 of 2024 dated 24.07.2024.

The Ld. Advocate for the accused also authenticates the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date

I have perused the order of the Hon'ble Court passed in CRM (NDPS) 1138/2024 dated 24.07.2024. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

"...Accordingly, we direct that the petitioner, namely, Ashutosh Sarkar @ Ashu shall be released on bail upon furnishing a bond of Rs.25,000/- (Rupees Twenty five thousand), with two sureties of like amount each, one of whom must be local, to the satisfaction of Learned Judge, Special Court under the NDPS Act, Raiganj, Uttar Dinajpur. The petitioner shall appear before the trial court on every date of substantive subject to the provisions of Section 317 of the Code of Criminal Procedure and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever. The petitioner shall not leave the jurisdiction of the local police station except for the purpose of attending the court proceedings and shall report to the Officer-in-Charge of the said police station once in a week, until further orders. or commit similar offences in future.

In the event the petitioner fails to comply with any of the conditions stipulated above, the trial court shall be at liberty to cancel his bail in accordance with law without further reference to this Court".

In view of the aforesaid order of the Hon'ble Court, the accused **Ashutosh Sarkar @ Ashu** is permitted to furnish bail bond of Rs.25,000/- (Rupees twenty five thousand), with two sureties of like amount each, one of whom must be local to the **satisfaction of this court** regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action
