Record is put up today on the prayer of accused **Milan Kanti Singha @ Milan Singha** and by filing a petition he wants to surrender before this court and he has surrendered.

Accused is taken into custody.

The Ld. Advocate for the accused also files a petition releasing the accused on bail along with a copy of download server order of the Hon'ble High Court, Calcutta passed in CRM (A)2968 of 2024. The Ld. Advocate for the accused also authenticates the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date.

I have perused the order of the Hon'ble Court passed in CRM(A)2968 of 2024 dated 30.08.2024. On perusal of the order of the Hon'ble Court the Hon'ble Court was pleased to pass the following order:-

".....3. Accordingly, we direct that in the event of arrest the petitioner namely, **Milan Kanti Singha @ Milan Singha**, shall be released on bail upon furnishing a bond of Rs.10,000/-, with two sureties of like amount each, one of whom must be local, to the satisfaction of Arresting Officer and subject to and also comply with the conditions as laid down u/s.438(2) of the Cr.P.C, 1973 and on further condition that the petitioner shall appear before the Ld. Special Judge (Under NDPS Act), Raiganj, Uttar Dinajpur, corresponding to and on further condition that the petitioner shall appear before the Ld. Chief Judicial Magistrate, Asansol, Pashim Bardhaman, corresponding NDPS Case No. 03 of 2024 within two weeks from date and the petitioner shall not intimate the witnesses or tamper with evidence in any manner whatsoever. It is further ordered that the petitioner shall appear on every date before the aforesaid Court on and from the date fixed for appearance of the accused. In the event of non-compliance of any of the conditions, the anticipatory bail shall stand automatically cancelled without any further reference to this Court.

4. Accordingly, the prayer for anticipatory bail of the petitioner is allowed and the same is accordingly disposed of.

In view of the order of the Hon'ble Court, the accused **Milan Kanti Singha @ Milan Singha** be released on bail subject to furnishing a bond of Rs.10,000/- (Rupees Ten thousand only) with two sureties of like amount each, one of whom must be local to the satisfaction of the arresting officer and subject to the conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action
