Record is put up today on the prayer of Ld. Advocate made on behalf of accused Jaganath Sarkar @ Jagannath Sarkar @ Joga @ Jogh along server copy of order dated 08.03.2024 of the Hon'ble Court passed in CRM (NDPS) No. 453 of 2024, U/S 439 of Cr.P.C.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused Jaganath Sarkar @ Jagannath Sarkar @ Joga @ Jogh also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in CRM (NDPS) No. 453 of 2024 dated 08.03.2024. The Ld. Advocate for the accused also authenticate the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date.

I have perused the order of the Hon'ble Court passed in CRM (NDPS) No. 453 of 2024 dated 08.03.2024. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

"...4. Accordingly, we direct that the petitioner shall be released on bail upon furnishing a bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local, to the satisfaction of the Learned Judge, Special Court under NDPS Act,-in-Charge, Raiganj, Uttar Dinajpur, subject to conditions that petitioner shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses or tamper with evidence in any manner whatsoever.

5. In the event the petitioner fails to appear before the trial court without justifiable cause, the trial court shall be at liberty to cancel his bail in accordance with law without further reference to this court".

In view of the aforesaid order of the Hon'ble Court, the accused **Jaganath Sarkar @ Jagannath Sarkar @ Joga @ Jogh** is permitted to furnish bail bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local to the **satisfaction of this court** regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action.
